I have also been at the forefront of the efforts to defend that rule from being overturned in the legislature.**

To defend our victories we must continue to fight against mandatory minimums and efforts to undermine the cash bail reform efforts. My work included fighting for police accountability, First Amendment rights, voting rights, privacy, open government, criminal justice reform, immigrants' rights, women's rights, LGBTQ rights, and more. To cite two specific examples: I led the ACLU's legislative work on privacy and technology, ensuring that Marylanders are not tracked by law enforcement without search warrants, and I led the ACLU's legislative work on addressing the misguided war on drugs, which disproportionately affects people of color.**
