Additionally, in an effort to give back to the community, myself and my office have coordinated a number of pro bono expungement clinics both here in Cecil County as well as in Baltimore City. In 2018 alone we have provided free legal services for over 1,000 expungement petitions for citizens in either homeless, low income, or drug rehab facilities.

I will continue to be a defender of the 4th, 5, and 6th amendments and their applicable Maryland counterparts.
